

xmCHART 5.0 License Agreement

This binary code license ("License") contains rights and restrictions associated with the use of the accompanying X2max Software ("X2max") xmCHART software and documentation ("Software"). 1. License to Use. The Licensee is granted a right to use this Software and agrees to indemnify, hold harmless, and defend X2max and its licensors from and against any and all claims or lawsuits, including attorneys' fees, that arise or result from the use or distribution of Software.

2. Restrictions. Software is confidential copyrighted information of X2max and title to all copies is retained by X2max and/or its licensors. This includes the use of the Software in server-side scripts and in web-published databases for an unlimited number of WebDirect™ and Claris FileMaker Go™ users.

(b) *xmCHART Developer License*: The Licensee may distribute this Software (versions for Apple Inc. macOS, Microsoft Windows® and Linux Ubuntu) to its customers, subject to the following restrictions: The license must not modify or remove copyright notices or signatures that may be included within the software or displayed on the screen. The Licensee may only distribute the Software in conjunction with and as a part of the Licensee's own software products. The Licensee software products may include unbound native Claris FileMaker™ Pro solutions, commercial products and/or custom solutions designed specifically for the Licensee's clients or organizations.

(c) *xmCHART Runtime License*: The Licensee may distribute this Software (versions for Apple Inc. macOS and Microsoft Windows®) within a Claris FileMaker™ Runtime solution designed specifically for the Licensee's clients or organizations.

4. Trademarks and Logos. This License does not authorize the Licensee to use any X2max name, trademark or logo.
